

## **WOMEN OF TODAY – MOTHER’S DAY SWEEPSTAKES OFFICIAL RULES**

These are the Official Rules for the Women of Today Mother’s Day Sweepstakes (“Sweepstakes”). Your submission of an entry confirms that you meet the eligibility requirements and accept these Official Rules and the decisions of Women of Today, Inc. (“WOT” or “Sponsor”) concerning the Sweepstakes and these Official Rules.

### **ELIGIBILITY AND ENTRY**

**This Contest is open to legal residents of the United States, and the District of Columbia, who are 18 years of age or older at the time of entry.** Submission of an entry constitutes your agreement to these Official Rules and constitutes a binding contract between you and Sponsor.

Limit one entry per person.

Odds to win depend on the total number of eligible entrants. All entrants have an equal chance of winning.

If the potential winner is ineligible, or declines or forfeits the Prize, Sponsor in its sole discretion may conduct a further random drawing to identify an alternate potential winner. **The winner has 24 hours to respond to notification that the individual is the winner and to confirm.**
